Gymnast, and if minor, the undersigned, also acknowledges the fact that Sparta Gymnastics (the Academy) is not an insurer against injury and that Sparta Gymnastics offers its services to gymnasts at a cost which reflects the fact the Academy will not and can not be monetarily responsible for personal injuries which may occur to the gymnast while on the premises of the Academy. In consideration of this and in consideration of the right to participate in gymnastics and related activities: a) at Sparta Gymnastics, b) during competition and exhibitions on the premises of Sparta Gymnastics or elsewhere, c) during travel to and from Sparta Gymnastics, d) during travel to and from competitions, exhibitions, and other Academy related activities, the undersigned agrees to hold Sparta Gymnastics, its owners, its employees, its agents, owner of the premises upon which Sparta Gymnastics is located, or any anyone else harmless from liability for damages arising directly or indirectly as a result for personal injuries sustained by gymnasts due to: a) the negligence of the gym operator and/or the Academy owners, employees of the Academy, owner of the premises upon which Sparta Gymnastics is located, and agents or any other individual for whose acts the Academy might otherwise be liable; b) the defective quality or performance either as to the manufacture, design, location, or maintenance of any equipment or facilities used by Sparta Gymnastics in its business where the defective nature and/or dangerous propensity of said equipment or facility is known or unknown to the Academy, the gymnast, and/or the undersigned.
